ARTICLES OF INCORPORATION
(Under Chapter 1702 of the Ohio Revised Code)
Non-Profit Corporation

The undersigned, desiring to form a corporation, not for profit, under Sections 1702.01 et seq. of the Ohio Revised Code, do hereby state the following:

FIRST. The name of said corporation shall be Percy Lee Brown, Jr.

Memorial Scholarship Fund

SECOND. The place in Ohio where its principal office is to be located is Reynoldsburg

Franklin County, Ohio.

The Percy Lee Brown, Jr. Memorial Scholarship Fund is named in honor of the late Percy Lee Brown, Jr. of Steubenville, Ohio. He instilled pride, discipline, integrity, the need for preparation, the ethics of hard work and the rewards of hard work.
